EACH YEAR, RSWR DISTRIBUTES 22 TO 26 GRANTS IN THE AMOUNT OF \$6,500 TO \$7,500 IN GUATEMALA, KENYA, INDIA, AND SIERRA LEONE. THESE GRANTS ESTABLISH REVOLVING LOAN FUNDS OWNED AND MANAGED BY WOMEN'S GROUPS. THERE IS ONE CYCLE OF INITIAL GRANTS TO WOMEN'S GROUPS PER YEAR, WITH GRANTS APPROVED BY THE BOARD BASED ON THE RECOMMENDATIONS OF COUNTRY COORDINATORS. A SECOND ROUND OF \$3,000 GRANTS MAY ALSO BE APPROVED. BEFORE RECEIVING AN INITIAL GRANT, EACH GROUP MUST COMPLETE UP TO A YEAR OF PRE TRAINING WITH THE RSWR COUNTRY COORDINATORS, LEARNING ABOUT GRANT RESPONSIBILITIES, GROUP MANAGEMENT, SELF ESTEEM, AND SAVINGS AND LOAN BEST PRACTICES. ONCE FUNDED, THE COUNTRY COORDINATORS WILL WORK WITH EACH GROUP FOR THREE YEARS WITH THE FIRST YEAR BEING THE MOST INTENSIVE AS GROUPS LEARN TO MANAGE THEIR REVOLVING LOAN FUND AND BUSINESSES. EVERY SIX MONTHS TO A YEAR, DEPENDING ON THE GROUP STRENGTH AND EXPERIENCE WITH RSWR, FORMAL SITE VISITS WILL OCCUR TO REVIEW DOCUMENTS, ADDRESS CHALLENGES, AND PROVIDE GUIDANCE. ADDITIONAL FOLLOW UP VISITS MAY BE CONDUCTED IF NECESSARY. (CONTINUED IN SCH O)
